Device and Website Data

When you visit our website, we may automatically collect information such as IP address, browser type, device information, and website usage data through cookies or analytics tools.

2. How We Use Your Information

We use personal information to:

- Schedule and manage appointments
- Provide wellness services safely
- Process payments
- Communicate with you about bookings
- Manage memberships and service packages
- Improve our services and website
- Send service related notifications
- Comply with legal obligations
